4. Future Plan of Works for the Financial Year: 2018-2019:

- (i) Repairing and renovation of hospital staff canteen, the cost of which is approximately Rs. 3 lakhs.
- (ii) Installation of new 100 KVA Transformer (Domestic) at Sundari Mohan Seva Bhawan, the cost of which is approximately Rs. 7.00 lakhs. As per quotation from Trinayanee Electrical Engineering, an amount of Rs. 2.77 lakhs as advance already paid to Trinayanee Electrical Engineering (ASEB's/APDCL's approved electrical contractor), Ashram Road, N.H. Way, Silchar-7 by cheque on 06-03-2018. An amount of Rs. 1,17,576.00 paid to ASEB for cost of HT Trivector Energy Meter and Supervision charge as per their bill no. 84/25 dt. 06-06-2018 by Demand Draft on 29-06-2018.
- (iii) Construction of RCC drain next to main OPD Hall to protect erosion of soil, the cost of which is approximately Rs. 1.00 lakh.
